#### CANCELATION POLICY

While I will make every effort to reschedule in the event that you are sick or unable to attend your schedule class it is important to know that group activities may not be rescheduled as easily.

\*Cancellations due to sickness up to 24 hours ahead will be rescheduled at no additional charge. I would prefer that you do not arrive here sick or with a cold as I have a compromised immune system.

#### Cancellations for private lessons

All scheduled events must have a 50% deposit in place in order to confirm the dates and times.

#### Cancellations for group lessons
